9. Permission is granted for one time use only as detailed on the application form. Permission to publish must be obtained in advance for each subsequent edition or reprint. This permission is valid for a period of up to one year. If the publication has not appeared at the end of that time, permission is automatically revoked and must be requested again.
10. The permission hereby granted terminates immediately upon publication.
